

## Terms and Conditions for Participation in Pendleton Swim Club 2024

Welcome to Pendleton Swim Club! Thank you for your interest in our club. We're so excited for a fun and fast season! 1. The fees involved in the Pendleton Swim Club are as follows:

- **Splash Fee/Registration Fee:** A ***Splash Fee of \$65*** must be paid in full at the time of registration and is non-refundable. This is an annual fee. There is also a separate ***USA Swimming Membership Fee of \$85*** that covers our swimmers under our insurance and allows them to participate in swim meets. - **Dues:** The membership dues are based on your swimmer's group level and are listed on the fees schedule in this packet.
  - Monthly fees are due on the first of each month. If you select to enroll in auto-pay, funds will pull from your account on the 1st.
  - These **must be paid by the 18th of the month. If your account is not paid in full by the 18th, a \$25 late fee will automatically be assessed.**
  - If your account becomes 30 days overdue, your swimmer(s) may be asked to leave the water, and will not be allowed to participate in practice, meets or travel trips.
  - Please refer to registration packet and information during registration for the "Dues Schedule".
- **Meet fees:** For each of the competitions your swimmer enters in there will be fees for each event, including relays, in which they compete. Fees vary from meet to meet. These fees will be assessed on your monthly bill. ***These fees are owed even if your child does not attend the meet after signing up, as we pay the host teams the entry fees on the first day of the meet.***
- **Misc. fees/charges:**
  - Credit Card -- A convenience fee of approximately 3.50% of the payment amount will be charged by STRIPE for credit card transactions.
  - ACH-- If paying by ACH, there is a smaller convenience charged by STRIPE approximately 1.5%.

Convenience fees are non-refundable. There may be other fees/charges which can be assessed throughout the course of the year (i.e. travel trip expenses, meet fines, etc).

2. Participation in meets is optional.

3. All swimmers must swim "attached" to PSC from the first available day until the swimmer leaves PSC.

4. All swimmers competing for the Pendleton Swim Club must wear a team suit and Pendleton Swim Club swim cap during competition. Equipment requirements per each group are listed on our website [www.pendletonswimclub.com](http://www.pendletonswimclub.com) .
5. I understand that the club can use my contact information for corporate purposes and communication. I understand that PSC may contact me directly. PSC does not sell its membership list to third party services.
6. A place on our team is reserved for your swimmer. You are committing to join the Pendleton Swim Club for the season(s).
  - Should a swimmer decide to discontinue participation with the Pendleton Swim Club you must **notify the Business Manager** [businessmanager@pendletonswimclub.com](mailto:businessmanager@pendletonswimclub.com) **in writing**. The unused portion of the seasonal training fees is **not refundable** and any outstanding entry fees are considered an obligation to the Pendleton Swim Club and are payable upon termination of participation.
  - If a swimmer cannot participate due to injury and written documentation is provided to the PSC Head Coach and/or PSC Business Manager, the swimmer's account can be frozen until which time the swimmer can return to practice.
  - At the discretion of the Business Manager, dues and fees may be credited to the injured athlete's account to be applied for the following season when they return from injury.
7. Pendleton Swim Club reserves the right to dismiss any one person or entire family at any time for conduct not in line with PSC values or mission statements. This will be a no tolerance issue and may be used with the first occurrence.

I understand and agree to the above terms and conditions of the Pendleton Swim Club in exchange for the privilege of my child(ren), registered with this form, to participate in the activities and swimming program of the Pendleton Swim Club. I hereby release, discharge and agree to hold harmless the Pendleton Swim Club, Inc. and it's coaches, members of the Board of Directors, it's volunteers and employees, together with its successors, from any and all liability for injuries to property or person suffered as a result of participation as a member of the Pendleton Swim Club. I give the club authorization to connect with USA Swimming in regards to the membership of my child(ren).
