

DONNER SWIM CLUB

2026–2027 MEMBERSHIP FEES & ASSOCIATED COSTS

The Donner Swim Club membership year runs from **September 1, 2026 through August 31, 2027**.

Unless otherwise noted, membership fees are divided into **11 monthly installments from September through July**. There is no standard August installment.

Seasonal Registration Fee

\$50 per athlete per season

The annual registration fee is separate from monthly membership fees. The fee supports seasonal membership-related expenses including apparel, caps, banquet, and awards.

Training Group Fees

Other Associated Costs

Monthly membership fees do not necessarily include all costs associated with participation in Donner Swim Club.

Families will also be responsible for the applicable items:

- USA Swimming membership or registration fees;
- swim meet entry fees;
- required training equipment;
- team apparel or uniforms;
- competition suits and caps;
- travel and lodging expenses;
- replacement equipment;
- clinics or supplemental programming; and
- other optional or separately identified activities.

Any additional charges will be communicated before they are assessed whenever reasonably practicable.

Sibling Discount

Families with more than one registered athlete receive a 5% discount on the total monthly membership dues for the family.

The 5% discount applies to the combined monthly dues for all registered siblings and does not increase based on the number of additional athletes in the family.

The discount does not apply separately to each athlete and does not stack with each additional sibling.

Training Freeze

Donner Swim Club allows **one training freeze per membership year for up to four months**.

Approved freeze periods include:

- **Winter Freeze:** November through February
- **Summer Freeze:** April through July

Families requesting a training freeze must notify Donner Swim Club **in writing at least 30 days before the requested freeze begins**.

Athletes who are **rostered and actively participating on a high school swim team** will be **automatically enrolled in the Winter Freeze** for the applicable high school season and do not need to submit a separate freeze request.

[During an approved training freeze, the athlete remains a member of Donner Swim Club and the monthly membership fee is reduced to \\$55.](#)

A training freeze is not a withdrawal from Donner Swim Club. Families wishing to end membership must follow the Club's Withdrawal, Cancellation & Refund Policy.

Billing

Families are responsible for maintaining valid billing information and keeping their account in good standing.

Withdrawal, cancellation, missed-payment, and refund terms are governed by the **Donner Swim Club Membership Agreement** and the **Withdrawal, Cancellation & Refund Policy**.

Relationship to Other Club Policies

If an athlete changes training groups, the applicable membership rate may also change consistent with the Athlete Group Placement & Advancement Policy.
