<u>LOCATION:</u>	Levite Jewish Community Center 3960 Montclair Rd Birmingham, AL 35213
<u>FACILITY:</u>	Indoor 6 lane, 25 yard with non-turbulent lane lines, Colorado Dolphin timing system. The competition course has NOT been certified in accordance with 104.2.2C(4). The water depth is a minimum of 3.5 feet to feet. Warm-up/warm-down lane available at all times.
<u>RULES:</u>	<p>Current United States Swimming rules will govern the conduct of the meet. Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy (“MAAPP”), will govern this meet. Southeastern Swimming safety guidelines and warm up procedures will be in effect.</p> <p>The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms, locker rooms, or from behind the starting blocks. Deck changing into or out of swimsuits other than in locker rooms or rest rooms is prohibited.</p> <p>In the interest of safety and accident prevention, coaches and swimmers are asked to observe all posted pool rules and facility rules referred to in this meet information and to conduct themselves in a safe and prudent manner. Birmingham Swim League will not accept responsibility for anyone who climbs to an unsafe height for any reason.</p> <p>Drones are prohibited over venues any time athletes, coaches, officials and/or spectators are present.</p> <p>No Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet.</p> <p>1) A Technical Suit is one that has the following components:</p> <ol style="list-style-type: none"> 1. Any suit with any bonded or taped seams regardless of its fabric or silhouette; or 2. Any suit with woven fabric extending past the hips

<u>WARM-UPS:</u>	1:30 to 2:20 PM Southeastern Swimming safety guidelines and warm up procedures will be in effect.
<u>ELIGIBILITY:</u>	All swimmers must be 2025 USA Swimming Registered athletes. USA registration number must be included in the entry file. No entry will be accepted without current registration numbers. There will be no on-deck USA Swimming membership registration. Coaches and officials must present evidence of certification as required by Southeastern Swimming. A swimmer's age on the day of the meet will determine his or her age for the entire meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
<u>STARTING TIMES:</u>	Warm Up – 1:30 to 2:20 PM Competition – 2:30 PM
<u>ENTRIES:</u>	Entries must be emailed to chaz@sspro.info by the deadline of 1:00 pm Saturday, September 6, 2025 . All entries must be submitted via HyTek entry file. Teams who do not have their entries submitted by the deadline will only be allowed to swim in the meet at the discretion of the Meet Director and will be subject to deck entry in available lanes. Events will not be reseeded for late entries and new heats will not be created for late entries. Each club must print and sign the waiver of liability below. Waiver must be turned in before the start of the meet with team payment.
<u>ENTRY DEADLINE:</u>	Entries must be emailed to chaz@sspro.info as a HyTek entry file by 1:00 pm Saturday, September 6, 2025 .
<u>FEES:</u>	\$30.00 per individual swimmer. Electronic Credit Card, Check and cash accepted. One payment per club is preferred. All entry fees are nonrefundable. Make checks payable S&S . All check & cash payments must be submitted to the clerk of course, at the computer table.
<u>LIMITS:</u>	Each swimmer may enter a maximum of five (5) events for the meet. One (1) event per session.

<p><u>MEET FORMAT:</u></p>	<p>This will be a timed finals meet. The Block Party format means USA Swimming registered coaches will act as Stroke & Turn Officials.</p> <p>Our first goal is to offer an opportunity for new parents to become stroke & turn officials in a fun, educational environment. We have separated each stroke into its own session to allow new officials the opportunity to focus on one stroke at a time.</p> <p>We also want to encourage swimmers to swim all strokes and try all distances by providing an opportunity for them to make informed strategic decisions about their event selection.</p> <p>SEEDING – The meet will be seeded fastest to slowest by distance and time to allow for the most competitive races possible.</p>
<p><u>ENTRY ERRORS:</u></p>	<p>A psych sheet and/or heat sheet will be emailed for review after the entry deadline. If there is an error, the swimmer will be deck-entered into an open lane of the heat nearest his/her entry time. The entire event will not be reseeded.</p>
<p><u>SCRATCHES/ PENALTIES:</u></p>	<p>All scratches should be submitted to the Clerk of Course by 2:15 pm the day of the competition. A swimmer may scratch a pre-seeded event on the block without penalty. A swimmer may not scratch from one event to enter another event.</p>
<p><u>VOLUNTEERS & OFFICIALS:</u></p>	<p>The Block Party format allows for the USA Swimming certified coaches to act as stroke & turn officials during this meet.</p> <p>Officials and apprentices from visiting teams are welcome and appreciated. Please contact Mandy Johnson (mjohnson@opelika-al.gov) with session(s) you are available to work. Dress in khaki pants/shorts/skirts, white shirts and white shoes. Please fill out information on “Team Information” page to be returned with entries. Officials must be members of USA Swimming and must present evidence of certification as required by Southeastern Swimming. Should there be any questions, meet officials will recognize only coaches or their designated representatives.</p> <p>An officials’ meeting will take place at the Starter’s Table 30 minutes before the start of the meet. Timers’ meeting will take place at Clerk of Course 15 minutes before the start of the meet.</p>
<p><u>COACHES’ MEETING:</u></p>	<p>A coaches meeting will be held 10 minutes prior to the start of the meet at the computer desk.</p>
<p><u>RESULTS:</u></p>	<p>Results will be posted in Meet Mobile.</p>

2025 Waiver, Acknowledgment, and Liability Release

I the undersigned coach or team representative, verify that all of the swimmers and coaches listed on the enclosed entry form/team information are registered and entered into the meet in accordance and subject to USA Swimming Rules and Regulation:

1. All Clubs, including seasonal clubs, shall ensure that all athletes and coaches participating in USA Swimming sanctioned competition(S) are members of their LSC and USA Swimming.
2. All coaches of USA Swimming clubs, including seasonal clubs, shall join USA Swimming as coach members and shall satisfactorily complete safety training required by USA Swimming.

And as:

False Registration – A host LSC may impose a fine up to \$100.00 per event against a member coach or a member club submitting a meet entry which indicates a swimmer is registered with USA Swimming when that swimmer or the listed club is not properly registered.

I also acknowledge that I am familiar with the rules of USA Swimming and Southeastern Swimming, Inc. regarding warm-up procedures and meet safety guidelines, and that I shall be responsible for the compliance of my team's swimmers with those rules during this meet.
