

Acknowledgment of Member Obligations

1. The amount of Registration Fees, Program Dues, Fundraising Commitment, and Volunteer Shifts for which I am responsible is detailed on the BSL website, www.SwimBSL.com
2. I will be obligated to pay the organization **\$50 for each unearned Volunteer Shift** at the end of the swim year or at the termination of my membership, whichever occurs first. However, I understand and agree that I will not be entitled to any refund or credit for shifts earned in excess of the Volunteer Shift Commitment as described below (Commitment is per family):

Senior & Senior Elite	12 Points
Age Group Performance & Refinement	8 Points
Age Group Development	4 Points
Volunteer Shift =	1 Point

3. Program Dues are paid via Credit Card or from your bank via ACH. I understand that should my account for dues be in arrears, then no family member may swim in meets or practice until the account is made current or payment arrangements have been approved by the Program Director. I further understand that should my account be in arrears and payment arrangements have not been approved by the Program Director, then further disciplinary action by the Program Director may result that may include termination of membership from BSL.
4. **I understand that I may terminate my membership by giving the Program Director / Head Coach 60 days advance, written notice of the termination date.**
5. I understand that if my membership is terminated, either voluntarily or involuntarily, all sums owed are due and payable immediately, including Program Fees, Fund-raising Fees, and compensation for unearned Volunteer Shifts. I also understand that should termination occur, I will owe interest on the unpaid amounts owed to the organization at the rate of 10% per annum.
6. I understand that the Board of Directors may terminate my membership with or without cause. If the Board chooses to terminate my membership without cause, I will receive a pro-rata return of any unearned program fees.
7. I agree that should the organization have to pursue collection for sums owed to BSL that I will be responsible for any and all costs, expenses, and reasonable attorney fees associated with pursuing the sums owed.
8. I agree to assume responsibility for damages to property caused by my family members. I further agree to indemnify and hold harmless BSL, its officers, directors, employees, or agents, for claims, demands, or actions arising out of any injury or damages to persons or property caused by my family members or guests of my family members.

9. I understand that BSL will apply a \$10 surcharge to each swimmer's meet entries for home and away meets.
10. I understand that membership is renewable annually and that all terms and provisions apply throughout subsequent renewals.
